Bylaws

Bylaws from last meeting were tabled until a quorum was present. We do not have a quorum again so they will be tabled again until April meeting.

Kierstin recommended holding elections for 2015-2016 school year SCC in spring. Elcena will make a flyer advertising open positions for parents.

CSIP:

- Because we have too few members in attendance to vote, we will instead ask SCC members to come into the office to sign.
- Our CSIP from last year was based on Rate of Increase (ROI). To better align with the districts goals, this year we are writing our goals to target % of students on benchmark.
- Reading Goal: By May 2016, at least 80% of students will meet grade level benchmarks as measured by FSF/PSF and R-CBM, or grade levels will increase the number of students at benchmark by the following percentage: K-1=20%, 2-5:10%
- Kierstin talked about potential items to consider for the CSIP we will be writing next year.
- Elcena mentioned that perhaps next year we could align CTESS expectations with CSIP goals.
- Michelle remarked that it would be good for parents and SCC members to be aware of what the teacher evaluation system (CTESS) looks like.
- Math Goal: by May, 2016 at least 80% of students will meet grade level benchmarks as measured by the QD/MN and MCOMP, or grade levels will increase the number of students at benchmark by 20%.
- PBIS Goal: By May 2016, the number of office referrals will have decreased by 10% from the 2014-15 school year. Oakdale will establish and maintain a school-wide adult PBIS system.
- Elcena and Polly noted that we don't have very accurate PBIS data from this year to base a goal on.
- Angela requested teacher PD for Office Discipline Referrals (ODRs) and PBIS expectations for students and staff.
- The PBIS goal's action plan was modified to say "Staff-wide PBIS trainings for staff and student ODRs and School-Wide expectations
- Land Trust money will go to pay for 3 Reading Interventionists (\$19,000) and 1 Math Interventionist (\$6,000)

- Outlined acronym definitions for parent members
- Michelle asked why PBIS was a component of the CSIP – Kierstin explained that is a district initiative to address behavior and increase instructional quality
- Kierstin suggested that next year SCC meets monthly and also have each grade report their progress and feedback on the CSIP yearly.

Elementary Schedule & Tentative Brain Booster Choices

- Oakdale teachers voted from 6 choices: music, Playworks/PE, STEM, Library, art, and technology.
- Library is required for all schools.
- Teachers chose music, Playworks, STEM as our Brain Boosters.
- Michelle suggested we do Meet the Masters or something like it to continue bringing art to the classroom.
- We could not dedicate much time to additional programs due to reduced instruction time.
- Discussion about aides and retention.
